Welcome to the Sandy Pond **Beach Natural Area**

Sandy Pond Beach lies at the heart of a 17 mile long barrier system stretching from the Salmon River north to El Dorado Beach along the eastern shore of Lake Ontario. This barrier system consists of a sand beach, dunes, flats, and wetlands unique in New York State. This dynamic system supports a mosaic of plant and animal communities some of which are evident at Sandy Pond Beach. In 1995, the New York State DEC, The Nature Conservancy, and The Friends of Sandy Pond Beach joined together to establish and manage the Natural Area for nature and people.

Along with

beach grass and cottonwood trees, this rare shrub traps sand to form dunes.

What We Hope to Accomplish

- Preserve and restore the dunes.
- Protect feeding, resting, and nesting habitats for migrating and breeding birds.
- Provide compatible public access. .



Natural Area User Guidelines

To facilitate our goals, we ask visitors to observe the following:

- Visitor hours: open to the public beginning half an hour before sunrise to half an hour after sunset.
- Stay on the beach. No trespassing on the dunes or other protected areas. Walking over dunes damages stablizing vegetation and accelerates dune erosion, defeating the protective function dunes provide.
- Camping, open fires, and glass containers are prohibited, although self-contained heaters are permitted.
- No vehicles of any kind.
- Dogs must be kept on a leash.
- Respect private property. Note locations of private property on the map of the Area.

Conservation of Sandy Pond Beach Depends on You!

- Use designated dune walkovers to cross dunes.
- Pick up trash, and recycle or dispose of it properly. "Pack it in, Pack it out."
- Encourage appropriate behavior by others.
- Report any destructive behavior to the Dune Stewards, or the DEC Forest Ranger at (607) 753-3095 ext. 217.
